RULES & REGULATIONS

Participants must agree to abide by all rules and regulations for the duration of the race. The Local law will prevail at all times.

1. **ELIGIBILITY**
The Padawan Raft Safari 2017 under the kayak competition is open to both Malaysian and foreign participants **above the age of 18 years**. The kayaking is not limited to countries.
2. **SUBMISSION OF ENTRY**
Entry to kayaking is open now. Receipt of the entry form will constitute the participant's intent to enter the race and it is further acknowledge that the participant understand and agree to comply with each and every rule as stated. Closing date will be on **22nd September 2017 (Friday) at 12.00 noon**. Entries are determined on a first come, first served basis upon full payment of race entry fees. Intending competitors are required to register as early as possible. The organizer, Padawan Municipal Council reserves the right to reject any entry without giving any reasons whatsoever. There will be no refund of withdrawal after entries have been accepted, except when the competition is cancelled due to unforeseen circumstances. Late entries may at the discretion of the Organizer be accepted subject to their signing of the letter of indemnity.
3. **PRIZES**

Note: The organizer reserves the right to amend any of the above prizes without prior notice to the participants.

4. **STARTING/FINISHING POINTS**
The starting point/flag off for Kayaking is at Kpg. Annah Rais at 7.00 am while the finishing point for all categories will be at Kpg. Git. Team leader and Team Manager will be requested to attend a briefing on 21st September 2017. The time & venue for the briefing will be notified before the race.
5. **PARTICIPATING FEE**
(i) Kayak Competition – RM60.00 per registered participating team inclusive of personal accident insurance.
6. **THE TEAMS**
Only two (2) persons are allowed in one team for the kayak competition of which can comprise solely man, women or mix double.
7. **SAFETY**
It is compulsory to wear a safety jacket at all times during the race. Non-compliance will result in immediate disqualification. The organizer reserves the right to enforce the withdrawal of any number of competitors whenever the safety or health of competitors are endangered.
8. **PROHIBITION OF OUTSIDE ASSISTANCE**
Outside technical assistance or any powered assisted is not allowed during the race. Competitors may exchange paddles to assist each other. Any competitor deemed by Organizer to have used outside assistances or any form of powered assisted will be disqualified.
9. **DISCIPLINE**
Conduct that, to the opinion of the organizer, threatens the safety of competitors, spectators, officials or member of the public, foul languages, and other unsporting or anti-social behavior will be considered cause for disciplinary action. Such on the part of participant will subject him or her to either warning or immediate disqualification.
10. **TYPES OF CRAFT**
Kayak which can participate in the Kayak Competition are K1,K2,C1,C2 and RR. Competitors are requested to bring their own kayaks or rent the Kayak for the race.
11. **THE SCORING**
The Winner is the competitor completing the race in the shortest Total time. In the event of a tie, the competitor wins the best time in the final leg (Kpg. Semadang bridge Towards Kpg. Git) will be the winner.
12. **PROTESTS**
Protest must be submitted in a protest form provided by the organizer with a deposit of RM200.00 and delivered to the jury of appeal within 30 minutes of the posting of the results. The protest should contain information, such as description of incident, names of witness, name(s) of the affected party/parties, local address of complainant and the signature of the complainant.
13. **INSURANCE**
Whilst the entrance fee is inclusive of the premium for personal accident insurance, the organizer will **NOT** be responsible for any illness, injury, death, loss of baggage and personal items, occurring before, during or after the event. Nevertheless, late entries will not be eligible for the said personal accident insurance coverage.
14. **CHANGES NOTICE**
While the organizer tries to keep to the published itinerary as closely as possible, changes to schedule may be made to cope with the inclement weather or other factors, as may arise, at the discretion of the organizer.
15. **What is included**
Transportation from Kpg. Git. (Finishing Point) shall be provided upon request for those having parked their vehicles at Kpg. Danu or other Starting Points.
16. **What is excluded**
Airmfares, Airport Transfers, Camera and Video fees, alcoholic and non-alcohol beverages, transportation of kayak, optional tours and all other expenditure of a personal nature. Participants are responsible for their own accommodations.
17. **Health & Fitness**
Participant must have no physical or medical condition which would endanger himself/herself or interfere his/her ability to participate in the event.

All the above terms and conditions apply to the Padawan Raft Safari Kayak Competition. The organizer reserves the right to make any necessary adjustments to the event without prior notice.
