ALL TRAVELLERS UNDER **SINGAPORE – MALAYSIA VACCINATED TRAVEL LANE (VTL)** WILL STILL BE REQUIRED TO UNDERGO **QUARANTINE AT DESIGNATED QUARANTINE CENTRE UPON ARRIVAL IN SARAWAK IF ARRIVE LESS THAN 7 DAYS TO MALAYSIA. rt-PCR TEST 3 DAYS PRIOR TO ENTRY TO SARAWAK IF NEEDED**

LANGKAWI TRAVEL BUBBLE

TRAVELLERS ARRIVING FROM OVERSEAS UNDER **LANGKAWI TRAVEL BUBBLE** IS SUBJECT TO TAKE RT-PCR TEST 3 DAYS PRIOR TO ENTRY TO SARAWAK, AND MUST HAVE STAYED IN LANGKAWI FOR MORE THAN 7 DAYS, BEFORE ENTERING SARAWAK

NOTE: Failure to comply with these regulations can be charged under the Prevention and Control of Infectious Diseases Act 1988 (Act 342) and Protection of Public Health Ordinance 1999.

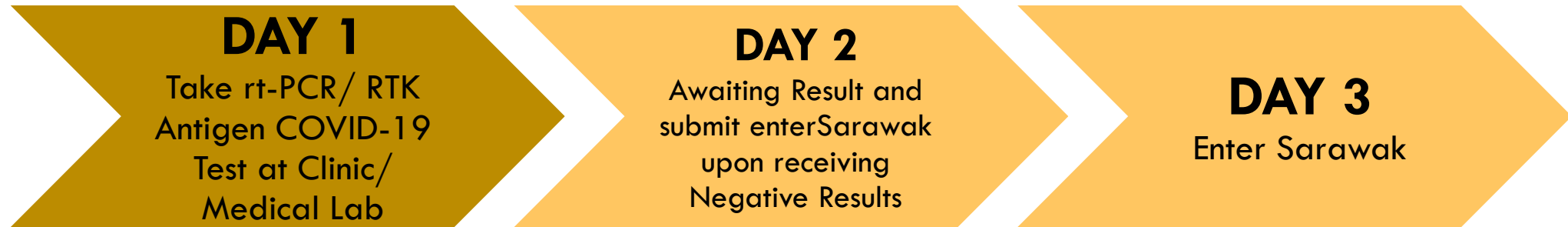

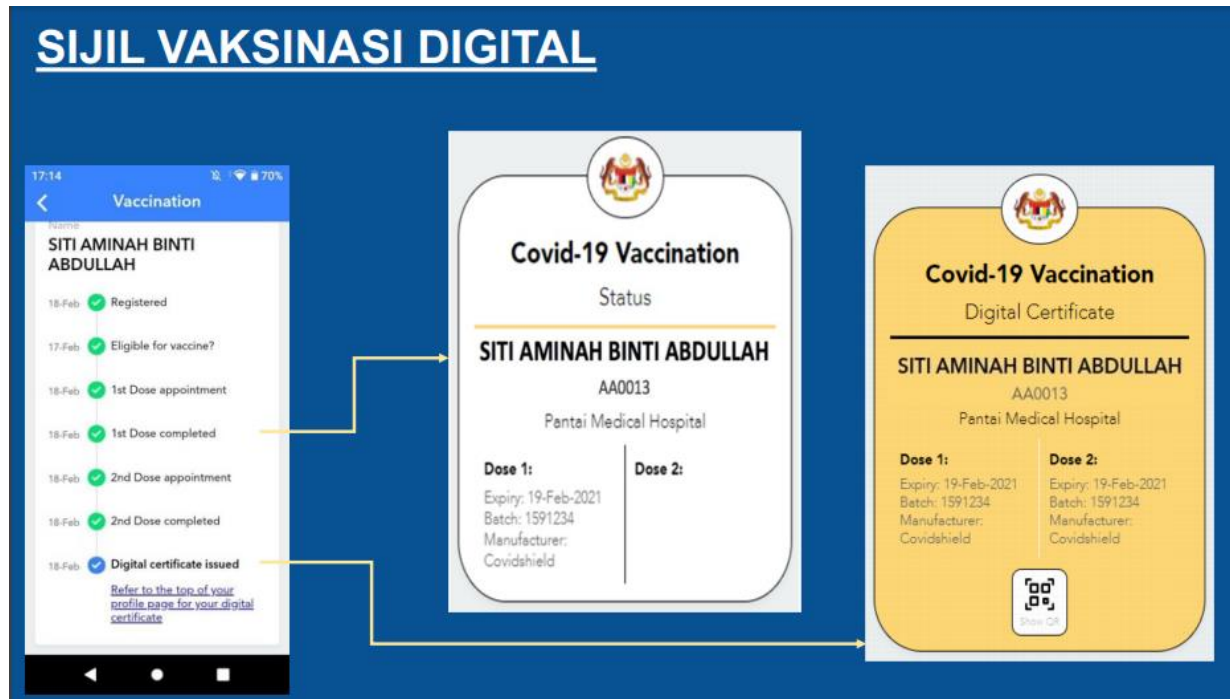
COVID-19 RT-PCR SWAB TESTS TO BE TAKEN ON DAY 8

RT-PCR / RTK ANTIGEN TEST (SWAB) VALIDITY — 3 DAYS VALIDITY PRIOR TO ENTER SARAWAK



- **COVID-19 RTK ANTIGEN SELF TEST KIT (SALIVA) IS NOT ACCEPTED**
- **FROM OVERSEAS THE 3 DAYS IS COUNTED PRIOR TO DEPARTURE FROM 1ST POINT OF DEPARTURE (BEFORE ENTERING MALAYSIA)**

VACCINATION DIGITAL CERTIFICATE



- TO ATTACH VACCINATION DIGITAL CERTIFICATE OR VACCINATION CARD

- ONLY COVID-19 VACCINE UNDER WORLD HEALTH ORGANIZATION IS RECOGNIZED

- REQUIRED TO CONVERT VACCINATION CERTIFICATE FROM OUTSIDE MALAYSIA INTO MYSEJAHTERA

DIGITAL CERTIFICATE OF COMPLETE VACCINATION 2 DOSES FOR APPLICANTS

COMPLETE DOSE IS DEFINE AS 14 DAYS AFTER DATE OF VACCINATION IS TAKEN (FOR DOUBLE DOSE VACCINE) OR 28 DAYS AFTER DATE OF VACCINATION (FOR SINGLE DOSE VACCINE)

ENTRY INTO SARAWAK

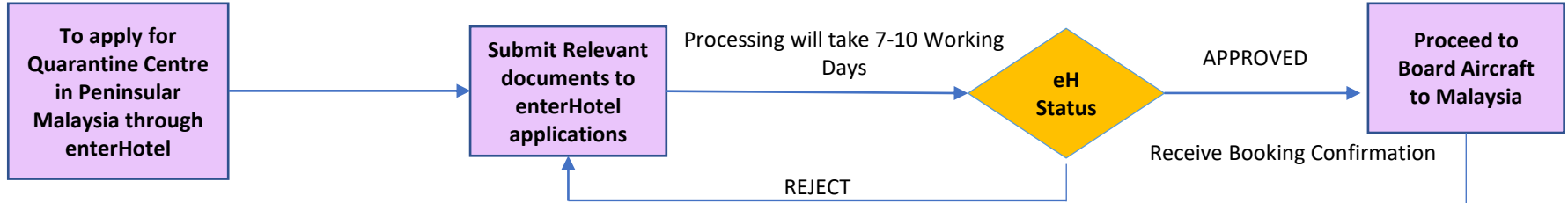
For travellers unvaccinated due to medical reason, they will be given **MANDATORY QUARANTINE** for 10 days. COVID-19 swab will be taken on day 8.

TRANSIT RULES

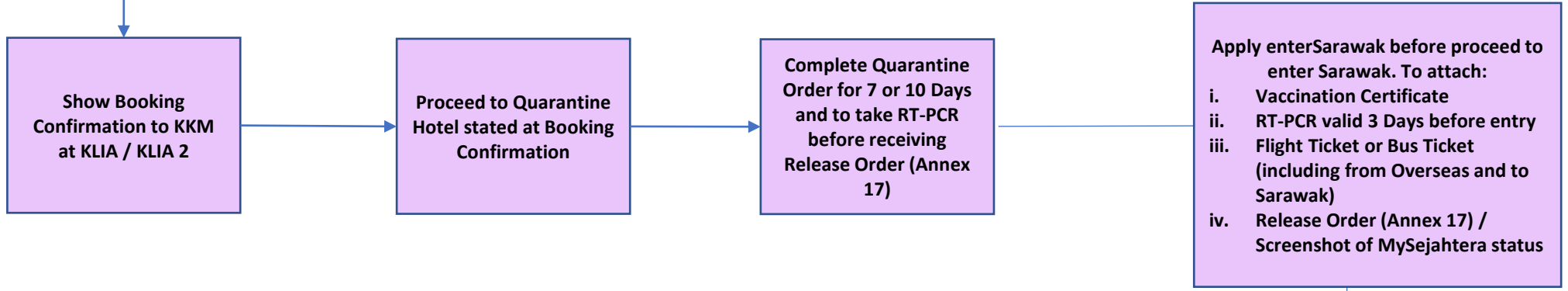
INTERNATIONAL TRAVELLERS:

- Sarawakian/ Sarawakian Spouse + Family travel from outside Malaysia and transit in Peninsular Malaysia is required to undergo **MANDATORY QUARANTINE** at 1st Point of Entry in Malaysia (KLIA/KLIA2)
- Enter Hotel for quarantine centre can be done through enterHotel <https://sarawakdisastermc.com/eshotel> via State Liaison Office Sarawak (Quarantine Centre in Peninsular Malaysia) within 7-10 working days prior departure to Malaysia.
- For Non-Sarawakian (including long term pass holder) is required to undergo **MANDATORY QUARANTINE** at 1st Point of Entry in Malaysia (KLIA/KLIA2) at own arrangement.

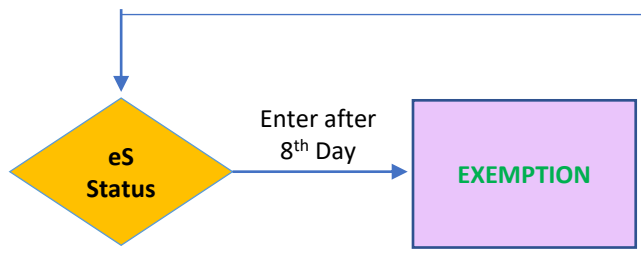
Passengers

KLIA/KLIA 2)

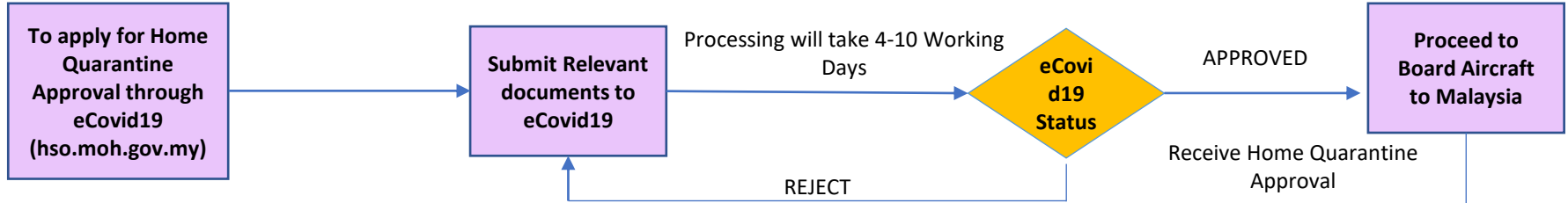


Passengers
(Arrival in Sarawak)

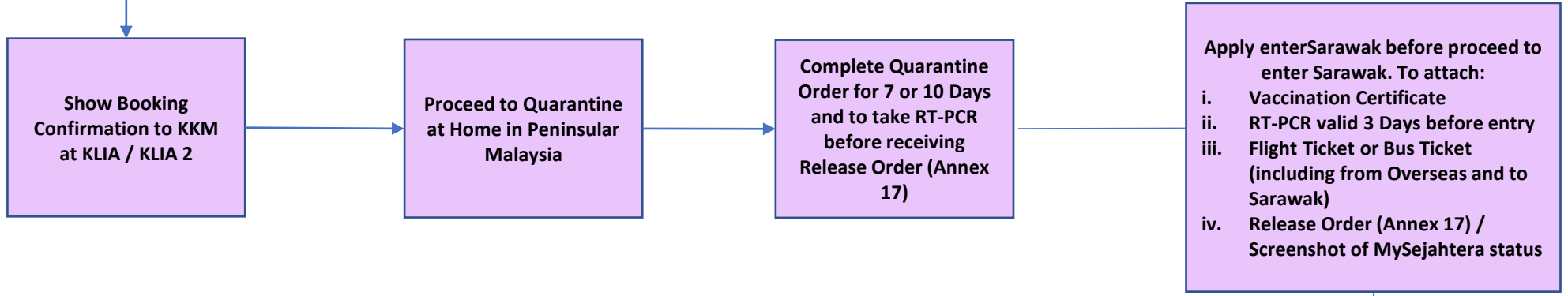

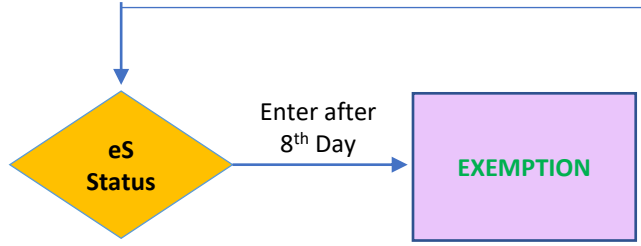

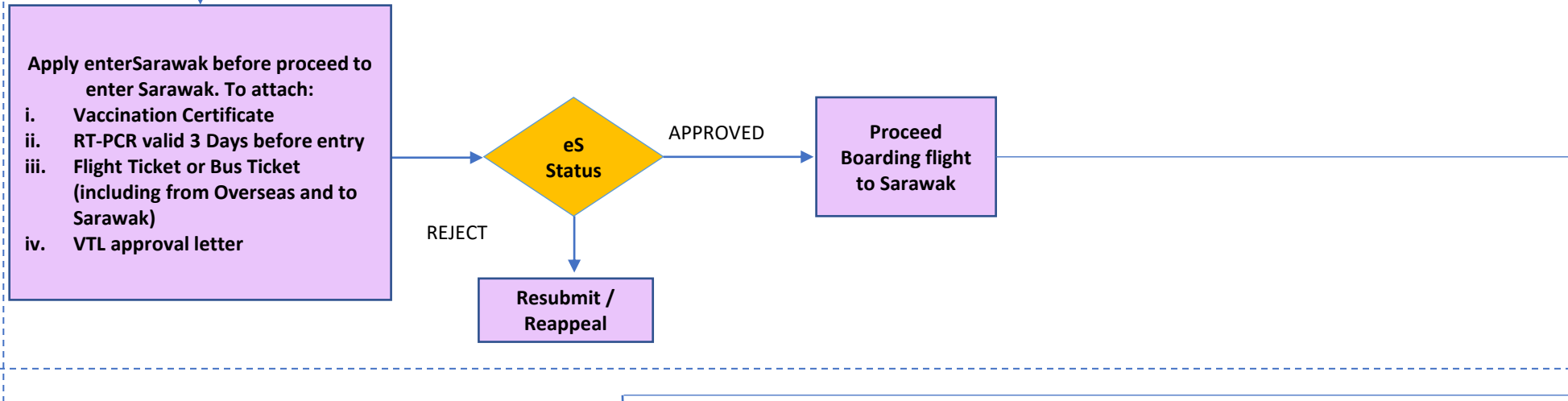

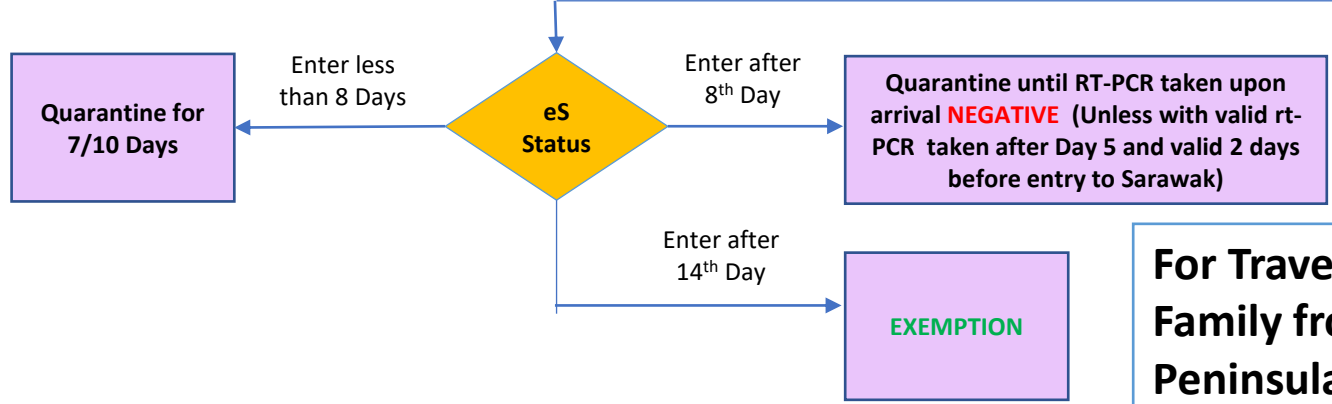
