THE ROAD TRANSPORT ACT 1987

THE ROAD TRANSPORT (PROVISION OF PARKING PLACES)  
(PADAWAN MUNICIPAL COUNCIL) ORDER, 2019

(Made under section 72)

In exercise of the powers conferred by section 72 of the Road Transport Act 1987 [Act 333], the Padawan Municipal Council, being declared an appropriate authority under section 67 of the said Act [P. U. (B) 289/92], has made the following Order:

**Citation and commencement**

1. This Order may be cited as the Road Transport (Provision of Parking Places) (Padawan Municipal Council) Order, 2019, and shall come into force on the 2nd day of January, 2019.

**Interpretation**

2. In this Order—

“Council” means the Padawan Municipal Council established under the Local Authorities Ordinance, 1996 [Cap. 20];

"goods vehicle" shall have the same meaning as assigned to that expression in the Commercial Vehicles Licensing Board Act 1987 [Act 334];

"motor vehicle" shall have the meaning assigned to it in the Road Transport Act 1987 [Act 333];

"parking" has the meaning assigned to it in the Road Transport Act 1987 [Act 333];

"parking coupon" or "coupon" means coupon or other document issued by the Council for the purpose of parking a motor vehicle in accordance with article 8;

"parking period" means the period prescribed in the First and Second Schedules during which a motor vehicle is allowed to be parked on payment of the prescribed fees;

"parking place" means any road or place specified in the First and Second Schedules, and includes any place in which the appropriate sign indicates that parking by motor vehicles is permitted;

"parking space" means the space marked out in a parking place for the parking of a motor vehicle;

"parking warden" means any person appointed by the Council as such, and includes any person authorized by the Council to perform the duties and to exercise the powers of a parking warden under this Order;

"public service vehicle" shall have the same meaning as assigned to that expression in the Commercial Vehicles Licensing Board Act 1987 [Act 334];

"prescribed fee" means the parking fees prescribed in the First Schedule payable by any person for parking a motor vehicle in a parking place;

"road" has the meaning assigned to it in the Road Transport Act 1987 [Act 333];

"season parking coupon" means the official receipt or any other document issued by the Council, showing the registration number of a motor vehicle and the amount of the prescribed fee for the parking of such vehicle in a specified season parking place for a period of time specified in such official receipt or document, and upon such conditions as the Council may deem fit to impose;

"season parking place" means a parking place specified in the First Schedule, wherein motor vehicles in respect of which a season parking coupon has been purchased may be parked;

“sign” means a sign under the Traffic Signs (Size, Colour and Type) Rules, 1957 [F.L.N. 167/59], and includes any sign or notice displayed by the Council for the purposes of this Order;

“unregistered motor vehicle” means any motor vehicle other than those exempted from registration under the Motor Vehicles (Registration and Licensing) Rules, 1957 [F.L.N. 173/59], which is without registration plates, or with expired registration plates, or with fictitious registration plates attached thereto;

“whole day parking place” means a parking place specified in the First and Second Schedules, wherein motor vehicle may be parked for a whole day in such parking place on payment of the prescribed fee.

#### Provision for parking places

3.—(1) It is hereby provided that the parking places specified in the First Schedule shall be used as half-hourly, whole day and season parking places for motor vehicles, other than public service vehicles, motorcycles or motor scooters and the fees to be paid for the use thereof shall be prescribed in the First Schedule.

(2) The Council may, by notification in the *Gazette*, amend the Schedules specified in paragraph (1).

(3) The Council may, impose parking fees in accordance with rates as prescribed in this Order in any public road or place vested in the Council or which is reserved for use as a public road or car park but which has not been included in the First Schedule to this Order, by publishing the appropriate notice in any local newspaper and by erecting the appropriate signs in respect thereof in the immediate vicinity of such public road or place, and the appropriate provisions of this Order shall apply thereto.

(4) Roads or places other than those mentioned in paragraph (1) shall be parking places for the parking of a certain class or description of motor vehicles as the Council may designate from time to time by the exhibition or erection of the appropriate signs thereat showing, *inter alia*, the class or description of motor vehicles to apply and the prescribed parking fees imposed (if any), and the appropriate provisions of this Order shall apply thereto.

(5) No person shall park or caused to be parked any motor vehicle on any road except in a parking place provided or designated for the parking of such motor vehicles.

(6) No motor vehicle shall be parked in a parking place where the sign indicates that the parking place is for the use of a certain class or description of vehicle, unless that vehicle belongs to that class or description.

#### **Council to determine type of parking system**

4.—(1) Pursuant to providing parking places, the Council shall, have the discretion to determine and implement the types of parking system including coupon parking system and any other systems which it considers suitable and the manner in which they are to be managed and the provisions of this Order shall apply thereto subject to such modifications as may be considered necessary.

(2) The Council may impose any conditions it deems fit in managing such parking places and such conditions shall be observed and complied with by every person intending to use the parking places provided.

#### **Season parking place**

5.—(1) On the application of the owner of any motor vehicle the Council may, upon payment of the fees prescribed in the Schedule, issue to such applicant a season parking coupon as set out in the Form D of Second Schedule which shall entitle the motor vehicles for such parking place or is duly authorized by the Council so to park which is not reserved under article 6(3) without further payment of the prescribed fee during the period for which the season parking coupon is issued not reserved under article 6(3) without further payment of the prescribed fee during the period for which the season parking coupon is issued.

(2) Any person using a season parking place shall display the relevant season parking coupon in the same manner as a vehicle licence is required to be displayed by rule 18 of the Motor Vehicles (Registration and Licensing) Rules, 1959 [F.L.N. 173/59], at all times when the motor vehicle is in the season parking place.

(3) The Council may at any time withdraw parking facilities from any season parking coupon holder without assigning any reason therefor. In such event, the Council may if the validity of the unexpired period of the season parking coupon is more than fifteen days, to refund to the holder of the season parking coupon half the sum for which the season parking has been issued.

(4) On the application of a person to whom a season parking coupon has been issued, while such season parking coupon is still in force and on the production by him of the season parking coupon and on payment of a fee of five ringgit, the Council may amend the season parking coupon to enable it to be used in respect of the motor vehicle mentioned in the application instead of the motor vehicle in respect for which the season parking coupon has been issued or the Council may replace the same with a new season parking coupon containing the same validity date.

(5) The holder of any season parking coupon shall inform the Council whenever his season parking coupon has been lost, destroyed, defaced or the particulars thereon have become illegible, and shall obtain a replacement thereof. The fee for a replacement season parking coupon shall be ten ringgit.

(6) A monthly season parking coupon shall be valid for the period for which it is issued.

(7) Where a motor vehicle is parked in a season parking place without a valid season parking coupon or had remained in a season parking place after the expiry of the authorized parking period specified in the season parking coupon, it shall be the duty of the parking warden to issue an advice note to be affixed to the windscreen or any conspicuous part of the motor vehicle requesting the owner of the vehicle to pay the prescribed parking fee and an additional excess charge of one ringgit for every hour or fraction thereof during which the motor vehicle had been parked in a season parking place without a season parking coupon or had remained parked in a season parking place after the expiry of the authorized parking period. Any person who fails to pay such sum within the period specified in the advice note shall be guilty of an offence: Penalty, a fine of not exceeding three hundred ringgit.

#### **Parking spaces**

6.—(1) A parking place may be divided into parking spaces and for the purpose of determining the parking spaces, the Council shall cause each parking space to be indicated by painted lines, studs, signs or other indications.

(2) There shall be erected at a parking place a sign or signs for the purpose of indicating parking spaces for the parking of a certain class or description of vehicle, and the prescribed fee and parking period imposed, if any.

(3) On the application of any person, firm, company, institution or organization, the Council may, at its own discretion, reserve any parking space for such person, firm, company, institution or organization, as the case may be, at a charge as may be prescribed and subject to such conditions as may be imposed by the Council from time to time.

#### **Method of parking**

7.—(1) No person shall park a motor vehicle in a parking space across any line marking the parking space or in such a position that the said vehicle shall not be entirely within the area delineated as parking space.

(2) A person parking a motor vehicle in a parking space shall, subject to the provisions of paragraph (1), cause such vehicle so far as the lines marking the parking space permit to face the general direction of traffic and shall conform to all signs and signals exhibited in such parking place.

(3) Where any motor vehicle is parked in a parking space in contravention of the foregoing provisions, a parking warden may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions, and the driver or person in charge of such vehicle shall comply with such lawful

instructions as a parking warden or a police officer in uniform may issue in order to comply with the provisions of this article.

**Parking without display of coupon**

8.—(1) No person shall park or cause or permit to be parked any motor vehicle in any parking place specified in the First Schedule without displaying on the motor vehicle in the manner prescribed by paragraph (1) of article 10 valid coupon prescribed by this Order having a value sufficient to meet the prescribed fee during which the said vehicle is parked or to be parked in that parking place.

(2) A parking coupon in Form A in the Second Schedule may be used in respect of any parking places specified in the first Schedule for the first half hourly parking.

(3) A parking coupon in Form B in the Second Schedule may be used in respect of any parking place specified in the First Schedule for the second half hourly parking.

(4) A parking coupon in Form C in the Second Schedule may be used in respect of any parking space specified in the First Schedule for third half hourly parking.

(5) A parking coupon in Form D in the Second Schedule may be used in respect of any parking space specified in the First Schedule marked for season parking.

**Irregular and invalid coupon**

9.—(1) No person shall display or cause or permit to be displayed on a motor vehicle any parking coupon that has any alteration, erasure or other irregularity therein which indicates that the parking coupon has been tampered with.

(2) A parking coupon or season parking coupon shall not be valid if —

(a) the coupon is so torn, defaced or mutilated that the figures or other particulars therein are not legible; or

(b) the period of validity of the coupon has expired; or

(c) the coupon, being a coupon in Form A in the Second Schedule does not indicate the time and date of commencement of parking the motor vehicle in accordance with article 10 (2); or

(d) the coupon, being a coupon in Form B in the Second Schedule does not indicate, the date of parking the motor vehicle in accordance with the instruction given in the form in which the coupon is set out.

#### **Manner of displaying coupon**

10.—(1) As soon as a motor vehicle is parked in a parking place at the designated parking place, the driver of the motor vehicle shall display one or more coupons either on the offside of the front windscreen or the offside front window of the motor vehicle in such a manner that the coupon is clearly visible from the front or offside of the vehicle and the coupon shall have the date, time of commencement of parking the said vehicle and other particulars indicated therein in accordance with paragraph (2).

(2) The date and time of commencement or continuation of parking a motor vehicle in a parking place shall, where required to be indicated in the coupon by this Order, be indicated in the coupon in accordance with the instruction given in the form in which the coupon is set out in the Second Schedule.

(3) No person shall display or cause or permit to be displayed on motor vehicle a coupon in which the time of commencement or continuation of parking indicated thereon is later than the actual time when he parks the said vehicle.

(4) Where two or more coupons are displayed on a motor vehicle to cover the period during which such vehicle is to be parked in a parking place, the time of continuation indicated in the second and subsequent coupon or coupons shall run immediately after the time of expiry of the period of parking indicated in the coupon of the prior period of parking.

(5) Any person who continues to park or causes or permits to continue to be parked any motor vehicle in a parking place after the expiry of the period in respect of which coupons are displayed on the motor vehicle to meet the prescribed fee shall be guilty of an offence.

#### **Issuance of coupon**

11. The Council or any person authorized on its behalf may issue to any person a coupon or coupons upon payment of the appropriate fees.

#### **Refund of unused coupon**

12. No refund shall be allowed for any unused coupons except in such special circumstances as the Council may allow and provided that the coupons are not defaced, mutilated or any other manner invalid.

**Production of coupon**

13.—(1) The parking warden or any person authorized by the Council may for the purpose of this Order require any driver of a motor vehicle parked in any parking place to produce for his inspection any parking coupon or coupons displayed on such vehicle and may retain any such parking coupon.

(2) If the driver of the motor vehicle fails to produce coupon or coupons displayed for inspection or retention by the Council or any person authorized on its behalf shall be guilty of an offence.

**Vehicles exempted from payment of fee**

14.—(1) Subject to the provisions of this Order, the following vehicles are exempted from payment of parking fee:

- (a) bicycles, tricycles and handcarts;
- (b) two-wheel motor vehicles; and
- (c) such other classes or description of vehicles as the Council may exempt in appropriate cases.

(2) The exemption from payment of parking fee in respect of any class or description of the vehicles specified in paragraph (1) may be withdrawn by the Council as it deems proper.

**Safety of other vehicles**

15. No vehicle shall be drawn, driven or pushed within a parking place otherwise than in an orderly and careful manner and with due regard to the safety of other vehicles and persons within the parking place.

**Unattended vehicles**

16. No motor vehicle in a parking place shall be left unattended unless it is rendered immovable by the application of brakes or by some other sufficient means.

**Suspension of use of parking places or spaces**

17.—(1) The Council may suspend the use of a parking place or space wherever it considers such suspension to be reasonably necessary —

(a) for the purpose of facilitating the movement of traffic or promoting its safety; or

(b) for the purpose of any building operation, demolition, or excavation adjacent to the parking space or the maintenance, improvement or reconstruction of the parking space or the laying, erection, alteration or repair



in or adjacent to the parking space of any sewer or of any cable, pipe, main or apparatus for the supply of water or electricity or of any telegraphic line; or

(c) for the convenience of occupiers of premises adjacent to the parking space on any occasion for the removal or delivery of furniture from or to any such premises; or

(d) on any occasion on which it is likely by reason of some special attraction that any road will be thronged or obstructed; or

(e) for the convenience of occupiers of premises adjacent to the parking space at the time of wedding or funerals or other special occasions; or

(f) for any other reason as the Council may deem fit.

(2) On any suspension aforesaid the Council shall cause to be affixed an appropriate sign or notice at or near the parking place or space in question, and it shall be unlawful for any person to park any motor vehicle in such parking place or space except in relation to a purpose for which the suspension was made.

#### **Reserved parking spaces**

18. On the application of any person, firm, company, institution or organizations, the Council may, at its own discretion, reserve parking spaces for such person, firm, company, institution or organization at a charge to be prescribed and subject to such conditions as may be imposed by the Council from time to time.

#### **Vehicles exempted**

19. This Order shall not apply to —

(a) any ambulance or any fire engine or any vehicle of the Armed Forces of the Federation, Visiting Forces and Police when used on official duty;

(b) any vehicle on active service of any authority authorized by or under any written law, or under any order having the force of any written law, to construct, erect or carry on electricity, water or other public undertaking, in so far as such vehicle is being used actively in the construction, erection or carrying on of the undertaking; and

(c) a vehicle which has been directed to a parking space by a police officer in uniform in the course of his duty.

### **Obstruction and removal thereof**

20.—(1) No person shall—

(a) place or cause to be placed any goods or other objects on any parking space or any part of a road adjacent to any parking space; or

(b) park or cause to be parked any vehicle on any part of a road adjacent to any parking space:

Provided that this provision shall not apply—

(i) to any vehicle stopping only for such time as is reasonably necessary to take up and set down passengers or load or unload goods; or

(ii) to any goods or objects placed at the aforesaid places only for such time as may be absolutely necessary for the loading or unloading of such goods or objects.

(2) A parking warden or any person authorized by the Council may remove any vehicle, goods or object which is the cause of any obstruction aforesaid or in respect of which there has been a contravention or non-compliance with any of the provisions of this Order; and the owner of such vehicle, goods or object may within twenty-one days of such removal or detention reclaim the same from the Council upon payment to the Council of the charges of removal and custody of the vehicle, goods or specified in the Third Schedule.

(3) Any unauthorized person removing or causing to be removed such vehicle, goods or object from the place of custody shall be guilty of an offence.

(4) The Council may at any time, if the goods or object aforesaid is of perishable nature, and after twenty-one days in any other case, dispose of the goods or object and shall refund the proceeds thereof to the owner less the cost mentioned in paragraph (2) and any other costs incurred in connection with the disposal; and in the event that the owner of the goods or object is not ascertainable, the proceeds mentioned may after twelve months of the disposal be credited to the revenue of the Council.

(5) The Council and its officers shall not be liable for any damage caused to the vehicle, goods or object in the course of its removal and whilst in the custody of the Council.

### **Prohibition on display of unregistered motor vehicles**

21.—(1) No person shall display or cause or permit to be displayed any unregistered motor vehicle in a parking place.

(2) Where any person is found or is reasonably believed to be displaying a motor vehicle for sale or carrying business in a parking space, a parking warden or any officer authorized by the Council may remove such motor vehicle.

(3) (a) Any motor vehicle which have been removed in accordance with this Order may be detained in a suitable place and to remain there at the risk of the owner until the costs of such removal and detention have been paid.

(b) The Council, its officers or any other persons acting under its expressed direction shall not incur any liability in respect of any loss or damage caused to any motor vehicle or fittings or contents thereof in the course of its removal or whilst it is being detained.

(4) If such motor vehicle is not claimed by its owner within three months of date of its detention, any officer authorized by the Council may sell the motor vehicle by public auction or otherwise dispose of such motor vehicle by giving one month notice in one publication in at least one local newspaper of his intention to do so.

(5) The proceeds from such sale or disposal shall be applied for payment of the costs of removal, detention and disposal of such motor vehicle or any other costs incurred in carrying out this Order and the surplus, if any, shall be paid to the owner or if the owner is not ascertainable or is not claimed by such person within twelve months after the date of such sale or disposal, shall be credited to the revenue of the Council.

#### **Removal and detention by Council**

22.—(1) If for any reason a motor vehicle has been left in the parking place without displaying thereon valid coupons or after the expiry of the period in respect of which the coupons are displayed, the Council may cause the vehicle to be removed from parking place to a place of safety and detained there until released by order of the Council and subject to payment of the charges specified in the Third Schedule.

(2) No motor vehicle detained under paragraph (1) shall be removed from the place of detention until all reasonable expenses incurred in carrying out the provisions of this article shall have been repaid to the Council.

(3) The Council and its officers shall not be liable for any damage to the motor vehicle or for any loss or damage to the fittings or contents of any motor vehicle so removed and detained by the Council under the provisions of this article.

#### **Notification of removal and detention**

23.—(1) When any motor vehicle, goods or object is removed or detained in pursuance of the provisions of Article 20, 21, and 22 the Council shall with all

reasonable dispatch give notice in writing to the owner thereof, if the name and address of such owner be known, of the removal or detention of such motor vehicle, goods or object.

(2) If after the expiration of twenty-one days from the date of service of the notice referred to in paragraph (1), the owner fails to claim for possession or release of such motor vehicle, goods or object, the Council may dispose of such motor vehicle, goods or object by public auction or in such other manner as it deems fit.

#### **Prohibition of trade or business**

24.—(1) No person shall use any motor vehicle parked in a parking space for the purpose of carrying on any trade or business.

(2) Where any person is found or is reasonably believed to be using a motor vehicle for trading or carrying on business in the parking space, a parking warden or any officer authorized by the Council may remove such motor vehicle together with its loads.

(3) (a) Any motor vehicle and its loads which has been removed in accordance with this Order may be detained in a suitable place and to remain there at the risk of the owner until the costs of such removal and detention have been paid.

(b) The Council, its officer or any other persons acting under its expressed direction shall not incur any liability in respect of any loss or damage caused to any motor vehicle or fittings or contents thereof in the course of its removal or while it is being detained.

(4) If such motor vehicle and its loads are not claimed by its owner within three months of the date of its detention, any officer authorized by Council may sell the motor vehicle by public auction or otherwise dispose of such motor vehicle and its loads by giving one month's notice in one publication in at least one local newspaper of his intention to do so provided that no such notice is required in the case of the goods and objects which are perishable in nature.

(5) The proceeds from such sale or disposal shall be applied for the payment of the costs of removal, detention and disposal of such motor vehicle or any other costs incurred in carrying out this Order and the surplus, if any, shall be paid to the owner or if the owner is not ascertainable or is not claimed by such person within twelve months after the date of such sale or disposal, shall be credited to the revenue of the Council.

#### **Prohibition of repairs**

25. No person shall repair a vehicle or permit a vehicle to be repaired parking place except in cases where minor repair is necessary to enable the vehicle to be removed from the parking place.

**Prohibition of washing or cleaning**

26. No person shall wash or clean or cause or permit to be washed or cleaned any vehicle in a parking place.

**Solicitation for employment**

27.—(1) No person shall solicit employment as a watchman at a parking place or for a parked vehicle.

(2) No person shall loiter at or near a parking place for the purpose of obtaining employment as a watchman for a parked vehicle.

**Removal of notice prohibited**

28. No person other than the person authorized by the Council shall remove or cause to be removed any notice issued by a parking warden and affixed to the windscreen or any conspicuous part of a motor vehicle whilst being parked in any parking place or space.

**Provision of signboards**

29. The Council shall provide a signboard or signboards at each parking place indicating the period during which motor vehicles or any particular class or type of vehicles may enter or use the parking place and stating the appropriate fee payable, and may erect such signs and signals as may be considered necessary for the direction or regulation of vehicles within the parking place.

**Emergency**

30. In case of any emergency, any person authorized in that behalf by the Council or any police officer in uniform, may move or cause to be moved to any place he thinks fit any motor vehicle left in any parking space.

**Penalty**

31. Any person who contravenes any of the provisions of this Order shall be guilty of an offence. Penalty, a fine not exceeding three hundred ringgit and in addition, there shall be paid to the Council any outstanding parking fees or charges due and payable to the Council.

**Registered owner's liability**

32. In cases of contravention of or failure to comply with any of the provisions of this Order, the registered owner of the motor vehicle shall be presumed to have contravened or failed to comply with such provision if the person (not being the registered owner) who actually contravened or failed to comply with such provision is not known or cannot be found.

**Council not liable for loss or damage**

33. The Council and its officers shall not be liable for any loss or damage to any vehicle or the fittings or contents of any vehicle parked in any parking place.

**Conduct of prosecution**

34. Prosecution in respect of any contravention of this Order including non-compliance of the conditions upon which parking places may be used, may be conducted by the Public Prosecutor or any person duly authorized in writing by him pursuant to section 377 of the Criminal Procedure Code [Act 593].

**Revocation**

35. The Kuching Rural District Council ( Parking ) Rules, 1971 [Swk L.G 40/1971] is revoked.

**Saving**

36.—(1) Nothing in this Order shall affect the past operation of, or anything done under the Rules is hereby revoked pursuant to Article 35 provided that any right, privilege, proceeding or liability existing at the date of commencement of this Order by virtue of the revoked Orders, shall be subject to this Order.

(2) Any prosecution, proceedings, action, claim or liability made, instituted, filed, commenced or incurred under the revoked Rules prior to the date of commencement of this Order, shall be deemed to be continued or have been incurred as if this Order has not been made.
